

Member Secretary of 'Academic Council' welcomed all the members and commenced the meeting as per the agenda:

1) Confirmation of the minutes of previous meeting held on 10th August, 2019.

The minutes of the 'Academic Council' Meeting held on 10th August, 2019 were passed unanimously by the members.

2) Approval to the exam pattern and grading system approved by BOS.

Principal Dr. Om Mahodaya, Chairman of Academic Council addressed the meeting about the status of examination and grading system due to current COVID-19 pandemic. On this Dr Patrikar made aware about the online teaching program adapted by VNIT (Autonomous) which was considered to be very useful.

Dr. Tekade briefed the council about the guidelines issued by UGC (**Annexure I**) regarding examination pattern and grading system. He also informed the council about the GRs issued by Government of Maharashtra (**Annexure II and Annexure III**). In view of this, 'Board of Studies' in various subjects discussed the issue and recommended to follow the guidelines of RTM Nagpur University, Nagpur. However, RTM Nagpur University, Nagpur had not issued the guidelines till date.

Academic council agreed with the decision taken by 'Board of Studies and advised to wait for the guidelines from RTM Nagpur University.

3) Paper Pattern (COVID 19) and Course Objectives & Outcomes :

Member Secretary informed the council that 'Board of Studies' of all subjects tentatively accepted one common pattern of examination for the Semester VI students who are willing to appear for examination. The pattern accepted by the BOS is attached in **Annexure IV**. He also informed the tentative timetable of B.Sc. Semester VI examination Summer 2020 (Non ATKT students who are willing to appear for the examination instead of grading based on previous year/semester performance). BOS of different subjects also discussed "Course Objectives and Outcomes".

Academic council noted the information.

4) Approval to the Panel of Question-Paper-Setters, Answer-Paper-Evaluators and Moderators Appointed by Board of Studies.

Academic Council is informed about the panel of Question Paper Setters, Answer Paper Evaluators, Moderators appointed by the Board of Studies. Council accord its approval to the same.

5) **Discussion on results under autonomy.**


Academic council discussed the results under autonomy and put the concern for UG results.

6) **Information about approval to the degree of UG and PG courses from RTM Nagpur University, Nagpur.**


