Following points were discussed during the meeting:

1. Dr. Mrs. N. P. Mohabansi welcomed all the external members of board of studies, Prof. Dr. Ravin M. Jugade, Prof. Dr. Hemant Chandak, Prof. Marazban Kotwal and Dr. Bhushan Popatkar. She informed all about the agenda of the meeting.

3. The draft of revised syllabus of B. Sc. with Chemistry for Semesters I and Semester II to be implemented from academic session 2023-24 was presented. 4. Mr. M. D. Bansinge presented the syllabus of skill enhancement course General Analytical Chemistry, Dr. P. G. Borkar – Pharmaceutical Chemistry, Dr. Mrs. N. P. Mohabansi – IT Skills for Chemists and Ms. B. U. Tale – Green Chemistry. Prof. Jugade suggested few modifications.
5. Shri. N. A. Barwat presented the syllabus of Generic Elective Course – Food Adulteration, Dr. A. V. Nakhate – Chemistry in Everyday Life and Dr. Ms. M. A. Haque – Safety Aspects in Laboratories. Prof. Chandak suggested addition of few topics.
6. The curriculum and mode of evaluation was thoroughly discussed by the members of the board.
7. The external members appreciated the efforts put in designing the whole structure and curriculum of the Major, DSC, SEC and GE courses.



Glad to approve the modified credit structure with more of practicals in the VSC and SEC as they are hands on courses.

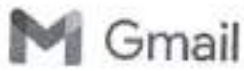
