- All the members of Board of Studies in Biotechnology subject approved the course code for the semester wise paper.

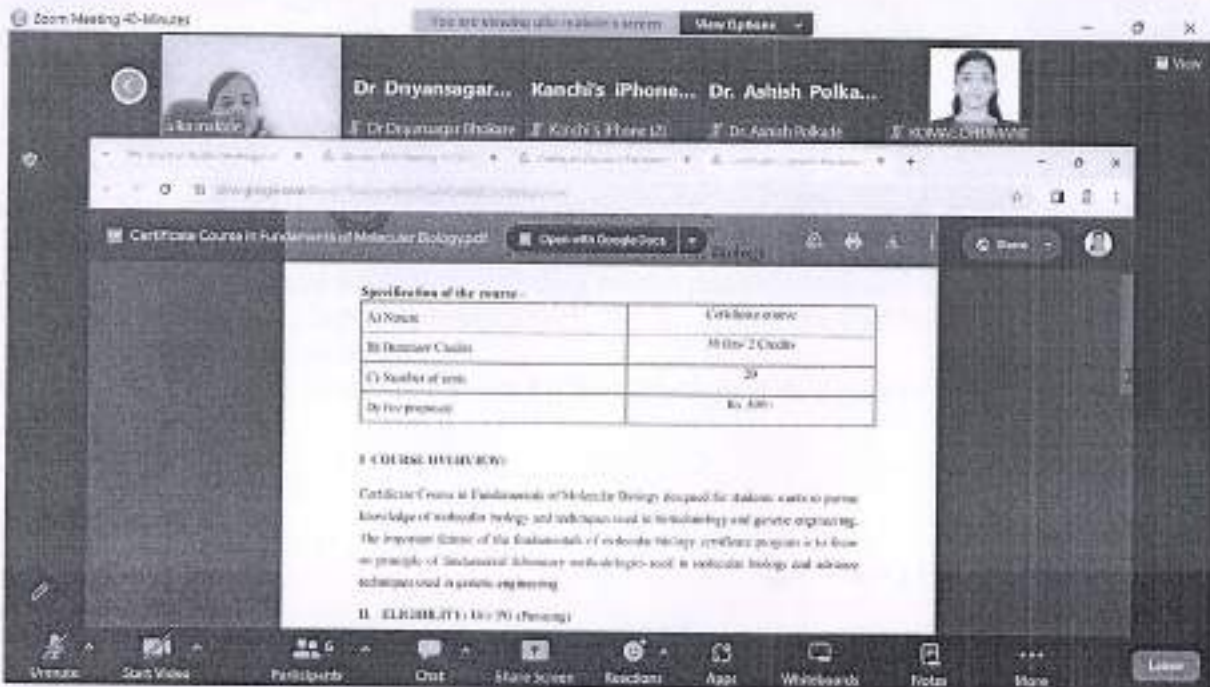
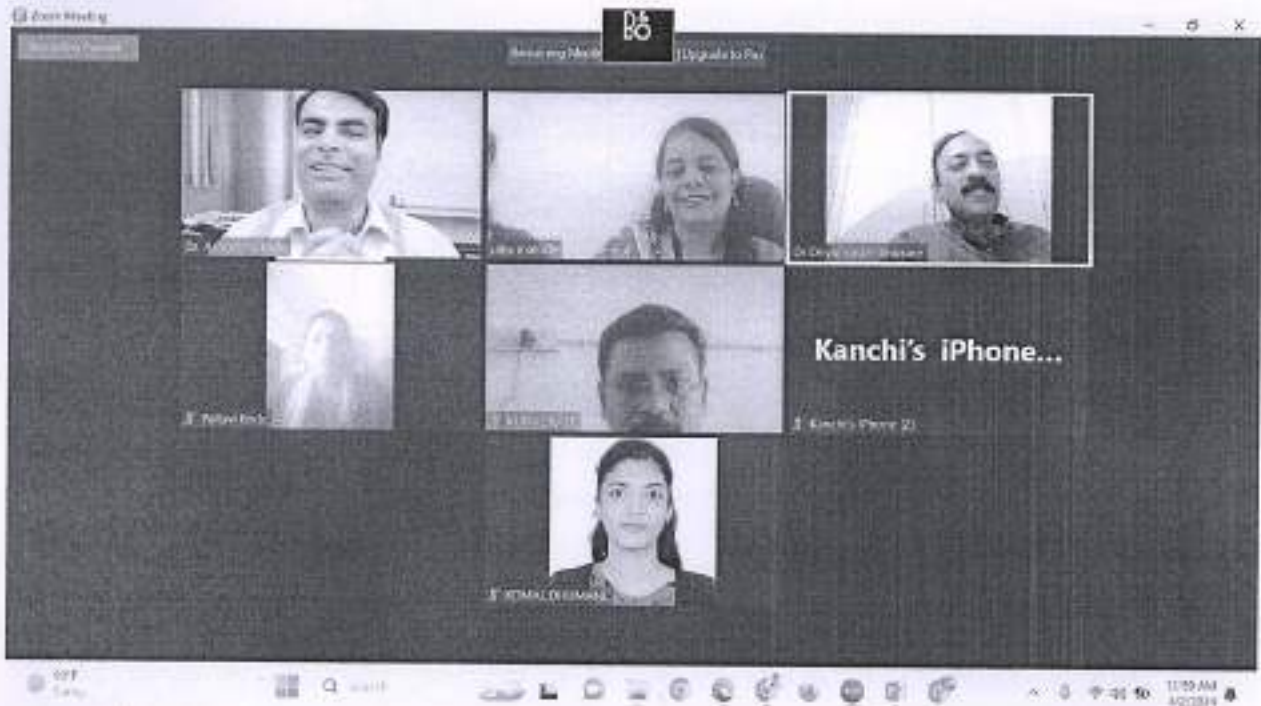
